



Rules for the NAAEE/Pierce Foundation Photography Contest

- Amateur Category – Persons who have not sold their images or have not finished in the top three in a competition.
- Advanced Category – Persons who have sold images or have placed in a competition.

Prizes

First Prize: \$500 for Amateur and \$500 for Advanced

Second Prize: \$300 for Amateur and \$300 for Advanced

Third Prize: \$200 for Amateur and \$200 for Advanced

Winning prints will be on display and prizes will be awarded at the NAAEE Conference at the Virginia Beach Convention Center, November 14-17, 2007.

The top 15 photos will be displayed on the NAAEE Web site and will be available in online greeting cards

The top three photos will be sold at the conference auction for the William Stapp Scholarship Fund

Format

1. Each print shall be placed on a 16 x 20 Matte Board or Foam Core Board.
2. Each print shall be mounted securely on the board.
3. Each print should be accompanied by a digital jpg file on a CD with identifying information. (more than one entry can be placed on one CD)
4. Each submission must have the application form attached securely to the back of the Matte Board or Foam Core Board.
5. Winners must provide model releases when necessary.
6. There is a maximum of five entries per person.
7. A fee of \$10.00 for each image must accompany your application. **(Checks and Money Orders Only! Make checks out to the NAAEE/Pierce Foundation Photography Contest)**
8. Each person must supply a self-addressed, stamped postcard that will verify receipt of your entry (entries). (One postcard will indicate your entries have been received if sent in one package. Otherwise provide a postcard for each if each is sent under separate cover.)

Photography Release and Waiver *(must be attached to all entries)*
